### Terms and Conditions

<b>Who is running the competition?</b>	The Promoter is the Elsternwick Mainstreet Committee (ABN 74 814 986 749), Suite 110/283 Glen Huntly Road, Elsternwick VIC 3185.
<b>When will the competition start and end?</b>	The competition starts at 12.01 am (AET) on 09/04/21 and ends at 11.59pm (AET) on 09/05/21.
<b>Who can enter?</b>	Only Australian residents can enter.
<b>Who can't enter?</b>	Directors, officers, management and employees of: <ul style="list-style-type: none"> <li>a) the Promoter;</li> <li>b) the agencies or companies associated with this competition or the Promoter; or</li> <li>c) the retail stores located in the Elsternwick Village precinct, and the immediate families of those people, can't enter.</li> </ul>

### **General**

- 14 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 15 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, or damage to, the prize.
- 16 The Promoter may communicate or advertise this competition using Facebook or Instagram. However, the competition is in no way sponsored, endorsed or administered by, or associated with, Facebook or Instagram. You provide your information to the Promoter and not to Facebook or Instagram. You completely release Facebook and Instagram from any and all liability.

### **Collection and use of your personal information**

- 17 The Promoter may collect your personal information directly or through its agents or contractors. The Promoter will use your personal information to conduct the competition. The Promoter may disclose your personal information to its related companies, agents and contractors to assist in conducting this competition, communicating with you or storing data.
