Terms and Conditions

Who can enter?	Only Australian residents 18 years of age and older can enter.
Who can't enter?	Directors, officers, management and employees of: a) the Promoter; b) the agencies or companies associated with this competition or the Promoter; or c) the retail stores located in Elsternwick Village shopping precinct and the immediate families of those people, can't enter.
