

# Find the golden eggs 2026 Competition Terms and Conditions

<b>Who is running the competition?</b>	The Promoter is Elsternwick Mainstreet Committee (ABN 74 814 986 749), Suite 110/283 Glen Huntly Road, Elsternwick VIC 3185.
<b>When will the competition start and end?</b>	The competition starts at 12.01 am (AET) on 10/03/26 and ends at 11.59pm (AET) on 10/04/26.
<b>Who can enter?</b>	Only Australian residents can enter.
<b>Who can't enter?</b>	Directors, officers, management and employees of: <ul style="list-style-type: none"><li>• a) the Promoter;</li><li>• b) the agencies or companies associated with this competition or the Promoter; or</li><li>• c) the retail stores located in the Elsternwick Village precinct, and the immediate families of those people, can't enter.</li></ul>
<b>Where will the competition run?</b>	The competition will run in participating stores ( <b>Store</b> ) in the Elsternwick Village precinct, in Victoria.

<p><b>How many winners will there be and how will they be chosen?</b></p>	<p>There will be 1 winner determined in respect of this competition.</p> <p>The draw will be held at 1pm (AET) on 13/04/26 at Suite 25, Level 2, 260 Collins St, Melbourne VIC 3000.</p> <p>The first valid entry drawn randomly from the entries received during the Competition Period will win the prizes.</p> <p>The Promoter may draw additional reserve entries and record them in order, in case the winning entry/entrant is deemed invalid.</p>

<p><b>If I win, when must I claim my prize?</b></p>	<p>You must claim your prize by 1pm (AET) on 11/05/2026.</p>

**What if I don't claim my prize on time?**

## **Prizes**

3. Any voucher prize is subject to the conditions imposed by the supplier of voucher including any validity period.

## **General**

You consent to the Promoter using your name and image in any promotional or advertising activity. Any images that we use to promote or advertise the promotion in this way will be used in perpetuity and will not be removed.

5. If you or your entry are deemed by the Promoter to breach these Terms and Conditions, your entry (or at the Promoter's discretion, all of your entries) may be discarded. The Promoter may, at any time, require you to produce documentation to establish to the Promoter's satisfaction the validity of your entries (including documentation establishing your identity, age, place of residence and place of employment). Failure by the Promoter to enforce any of its rights at any stage does not waive those rights.

6. You must not:

- (b) tamper with the entry process;
- (c) engage in any conduct that may jeopardise the fair and proper conduct of the competition;
- (d) act in a disruptive, annoying, threatening, abusive or harassing manner;

Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
15. Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, or damage to, the prize.
16. The Promoter may communicate or advertise this competition using Facebook or Instagram. However, the competition is in no way sponsored, endorsed or administered by, or associated with, Facebook or Instagram. You provide your information to the Promoter and not to Facebook or Instagram. You completely release Facebook and Instagram from any and all liability.

## Collection and use of your personal information

17. The Promoter may collect your personal information directly or through its agents or contractors. The Promoter will use your personal information to conduct the competition. The Promoter may disclose your personal information to its related companies, agents and contractors to assist in conducting this competition, communicating with you or storing data. By entering, you consent to the Promoter keeping your personal information on its database to use for future marketing purposes, including contacting you by electronic messaging.
