

EMC Halloween 2026 Competition - Terms and Conditions

Who is running the competition?	The Promoter is Elsternwick Mainstreet Committee (ABN 74 814 986 749), Suite 110/283 Glen Huntly Road, Elsternwick VIC 3185.
When will the competition start and end?	The competition starts at 12.01 am (AET) on 31/10/2026 and ends at 11.59pm (AET) on 31/10/2026.
Who can enter?	Only Australian residents can enter.
Who can't enter?	Directors, officers, management and employees of: • a) the Promoter; • b) the agencies or companies associated with this competition or the Promoter; or • c) the retail stores located in the Elsternwick Village precinct, and the immediate families of those people, can't enter.
Where will the competition run?	The competition will run in participating stores (Store) in the Elsternwick Village precinct, in Victoria.

General

15. Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, or damage to, the prize.

However, the competition is in no way sponsored, endorsed or administered by, or associated with, Facebook or Instagram. You provide your information to the Promoter and not to Facebook or Instagram. You completely release Facebook and Instagram from any and all liability.

Collection and use of your personal information
